### Pioneer Trails Recreation Area Sediment Removal from North Bay

### 1. INTRODUCTION

This Request for Proposal (RFP) is issued by the Upper Big Blue Natural Resources District, CONTRACTOR; to solicit proposals for removing sediment from the north bay of Pioneer Trails Lake, which is the area north of the East Road 14 bridge at Pioneer Trails Recreation Area located northeast of Aurora in Hamilton County, Nebraska.

Pioneer Trails Recreation Area is located in the Northwest Quarter Section 35, Township 11 North, Range 6 West and the Southwest Quarter of Section 26, Township 11 North, Range 6 West in Hamilton County, Nebraska. The area is located 1 mile north and 1.5 miles east of Aurora, Nebraska (address is 1714 East 14 Road, Aurora, Nebraska). (See Exhibits C-1, C-2, C-3, and C-4).

Pioneer Trails Dam was constructed on a tributary of Lincoln Creek in 1986. The project was designed to provide flood control, aquifer recharge, wildlife habitat, and recreation opportunities. The project features a 40-surface acre lake that can store 277 acre feet of water, with room for an additional 288 acre feet of flood storage. The lake's water source is supplied by rainfall from a 5,210 acre drainage area.

The crest of the dam is 15.0 feet wide with a crest elevation of 1763.7 feet. The dam has a 30 foot wide concrete spillway with a crest elevation of 1755.0 feet located near the center of the dam. The dam also has a 50 foot wide grass auxiliary spillway located at the east end of the dam with a control section elevation of 1759.0.

Existing facilities at Pioneer Trails Recreation Area include a boat ramp, amphitheater overlooking the lake, picnic shelters, a flush restroom, a vault restroom, a RV camping area, a tent camping area, grills, and a hiking trail around the lake.

2. EXAMINATION OF REQUEST FOR PROPOSAL DOCUMENTS AND EXPLANATION TO OFFEROR
Should the OFFEROR find discrepancies in, or omissions from the RFP, or should the intent or
meaning appear unclear or ambiguous, or should any other questions arise relative to the RFP,

its timely receipt by the CONTRACTOR. Replies to such notices will be addressed within 2
working days of receipt by the CONTRACTOR. If the request(s) require changes to the original
RFP, then an amendment to the RFP will be issued to all prospective OFFERORs and shared via
https://www.upperbigblue.org/about/bid-proposals. As reviewed by the CONTRACTOR, if a
request(s) is deemed significant, the CONTRACTOR at their discretion may extend the closing
date of the RFP.

### 4. AMENDMENTS TO REQUEST FOR PROPOSAL

If this RFP is amended, all terms and conditions that are not modified remain unchanged. The term "RFP" includes all exhibits and amendments provided by the OFFEROR as part of this RFP.

### 5. PREPARATION COST

The preparation of the proposal shall be by, and at the expense of, the OFFEROR.

### 6. PRICE CONDITIONS

The quoted price must include all costs to the CONTRACTOR for all supervision, labor, tools, supplies, materials, equipment, transportation, testing, and any other miscellaneous for full and complete performance of the work as set forth herein.

Pricing will be guaranteed for 90 days from submission of proposal. All pricing information requested in this RFP must be provided. Costing/Pricing by details must be broken down by labor, materials, etc. CONTRACTOR reserves the right to require the OFFEROR to furnish an accounting breakdown of all contract prices.

### 7. PAYMENT TERMS

CONTRACTOR payment terms are net 30 days upon receipt of invoice, subject to approval by the Upper Big Blue Natural Resources District Board of Directors.

### 8. RIGHT OF ACCEPTANCE

CONTRACTOR reserves the right to:

- Accept or reject any proposal in whole or in part.
- Reject all proposals, with or without, notice or reason.
- Enter into discussions or negotiations with OFFEROR prior to award. Negotiations do not
  constitute an acceptance of the proposal, nor rejection of the proposal, nor a
  counteroffer by the CONTRACTOR.

- Abandon the work or have the work performed in such a manner as CONTRACTOR may elect, if no proposal is accepted.
- Reduce the amount of sediment to be removed based on bid item and available funding.
- Adjust/increase the amount of sediment to be removed based on bid item and available funding, if agreed to be the selected OFFEROR.

### 9. PROPOSAL EVALUATION CRITERIA

While the CONTRACTOR intends to engage in the purchase of services, this event shall not guarantee that the participating OFFEROR will be awarded a Subcontract.

Any award resulting from this request will be made to the OFFEROR whose proposal provides the best value to CONTRACTOR. The best value determination will be at the sole discretion of CONTRACTOR and could result in an award to someone other than the lowest price proposal. Any resulting purchase award will be set forth in writing between the CONTRACTOR and the successful OFFEROR at some date after the close of the request. CONTRACTOR reserves the option to cancel this RFP process at a time and/or to elect not to engage in a Subcontract.

The OFFEROR must provide all data required in order to be considered an acceptable OFFEROR. All data must be executed completely, correctly, and accurately by the OFFEROR. Should the OFFEROR not complete all forms and documents, the OFFEROR will be deemed non-responsive.

This RFP will be evaluated based on the following criteria. OFFERORs are reminded the Subcontract will be awarded for best value with technical ability having the highest weighted percentage.

### 11. AWARD OF SUBCONTRACT

CONTRACTOR contemplates award of a Subcontract in accordance with the requirements and conditions set forth or incorporated by reference in this RFP.

Proposals for other than the total work defined may be rejected. The Award may not be made to any OFFEROR who has not responded to all instructions and representations indicated in the RFP.

CONTRACTOR may reject any or all proposals if such action is in the best interest of CONTRACTOR and their PARTNERS and/or waive informalities and minor irregularities in offers received.

CONTRACTOR and their PARTNERS may evaluate proposals and the CONTRACTOR award a Subcontract without discussions with OFFEROR. Therefore, each initial proposal should contain the OFFEROR's best terms.

CONTRACTOR reserves the right to conduct discussions, if later determined to be necessary by CONTRACTOR's Subcontract Administrator and Project Lead.

The OFFEROR agrees, if the proposal is accepted within the number of days allowed, to furnish all items upon which prices are offered, at the set price opposite each item, at the designated point(s) within the time specified in the schedule.

CONTRACTOR may reduce the amount of sediment to be removed based on bid price and available funding.

CONTRACTOR may increase the amount of sediment to be removed based on the bid price and available funding, upon agreement from the selected OFFEROR.

12. NOTICE TO SUCCESSFUL OFFEROR – W-9 Verification, Certificate of Liability Insurance CONTRACTOR will require any successful OFFEROR to supply a W-9 form (Request for Taxpayer Identification Number and Certification and a Certificate of Liability Insurance.

### 13. NOTICE OF UNSUCCESSFUL OFFEROR

The OFFEROR will be informed whether the proposal was successful using a method deemed adequate by the CONTRACTOR.

## Exhibit B BACKGROUND & SCOPE OF WORK

### **Project Background**

Pioneer Trails Recreation Area is located in the Northwest Quarter of Section 35, Township 11 North, Range 6 West and the Southwest Quarter of Section 26, Township 11 North, Range 6 West in Hamilton County, Nebraska. The area is located 1 mile north and 1.5 miles east of Aurora, Nebraska (address is 1714 East 14 Road, Aurora, Nebraska). (See Exhibits C-1, C-2, C-3).

Pioneer Trails Recreation Area is owned, operated, and maintained by the UBBNRD.

Pioneer Trails Dam was constructed in 1986 and features a 40-surface acre lake that can store 277-acre feet of water, with room for an additional 288 acre feet of flood storage. The lake's water source is supplied by rainfall from a 5,210 acre drainage area.

The crest of the dam is 15.0 feet wide with a crest elevation of 1763.7 feet. The dam has a 30 foot wide concrete spillway with a crest elevation of 1755.0 feet. The dam also has a 50 foot wide grass auxiliary spillway located at the east end of the dam with a control section elevation of 1759.0.

Existing facilities at Pioneer Trails Recreation Area include a boat ramp, amphitheater overlooking the lake, picnic shelters, a flush restroom, a vault restroom, a RV camping area, a tent camping area, grills, and a hiking trail around the lake.

### **Scope of Work**

The suggested scope of work is below, and prospective consultants should suggest any proposed alterations to this scope of work.


The tasks and specific steps for this study include the following:

- 1. Pump approximately 2,500 cubic yards of sediment from the basin north of the East Road 14 bridge. The sediment is approximately 1 foot deep across the entire 1.6 acre basin (see Exhibit D-1 and Exhibit D-2)
- 2. Construct a storage pit/basin to store sediment pumped from the north basin in an area as marked on the map included as Exhibit E and Exhibit F.
  - a. This storage pit should be approximately 150 feet by 100 feet by 4.5 feet deep.
  - b. Material excavated to construct the pit may be placed near the park entrance as shown on Exhibit E.
  - c. The pit should include a drainage pipe that can drain excess water back to the reservoir.




- 3. If additional material is needed to construct this storage pit, material is available near the park entrance as shown on Exhibit E. Use of this material should be coordinated with the Upper Big Blue NRD.
- 4. If additional storage space is needed from material removed to construct the pit, it may be hauled to the area near the park entrance, as shown on Exhibit E.
- 5. The OFFERER shall survey the constructed storage pit prior to pumping operations.
- 6. The OFFERER shall survey the storage pit following pumping operations.
- 7. The pre-pumping survey and post pumping survey will be used to determine the amount of sediment removed.
- 8. The OFFERER shall obtain any necessary or required permits to construct the storage permit.
- 9. The NRD plans to remove the silt material from this pit in the future, and to restore the pit area to it's original contours.
- 10. During construction, appropriate access and warning signs will need to be posted to close public access to the northwest parking area.
- 11. If the OFFERER plans to haul material to/from the borrow/waste area near the park entrance (Exhibit E), the OFFERER will need to post appropriate warning signs on East 14 Road.
- 12. The OFFERER will provide a weekly update on the project progress to the UBBNRD.
- 13. The OFFERER shall complete the work by close of business on June 12, 2026.


# Pioneer Trails Recreation Area – Location







Pioneer Trails – North Basin – 1.6 acres
