The Nebraska Department of Environmental Quality has awarded the City of York with a Source Water Protection Grant to expand educational programs in the City of York Wellhead Protection Area in partnership with the Upper Big Blue NRD. One of the programs offered to homeowners in the Wellhead Protection Area is a Rain Barrel Reimbursement. Rain Barrels capture and store roof water for later use in landscape/garden watering. This decreases stormwater runoff and provides water savings to homeowners.

- Homeowners are eligible for one reimbursement for the life of the program.
- Homeowners are eligible for reimbursement of the actual cost up to \$75.00 for the purchase of a Rain Barrel for use in their landscape.
- Purchases made before application approval are not eligible for reimbursement.
- Homeowners must complete this application and be approved for reimbursement before purchasing a Rain Barrel.
- Once purchased, an itemized receipt must be turned into the Upper Big Blue NRD Office at the address above for reimbursement approval.

I have read the Project GROW Rain Barrel Reimbursement Rules and understand that failure to meet the guidelines will result in loss of reimbursement.

Purpose of Form

An individual or entity (Form W-9 requester) who is required to file an information return with the IRS must obtain your correct taxpayer identification number (TIN) which may be your social security number (SSN), individual taxpayer identification number (ITIN), adoption taxpayer identification number (ATIN), or employer identification number (EIN), to report on an information return the amount paid to you, or other amount reportable on an information return. Examples of information returns include, but are not limited to, the following:

- Form 1099-INT (interest earned or paid)
- Form 1099-DIV (dividends, including those from stocks or mutual funds)
- Form 1099-MISC (various types of income, prizes, awards, or gross proceeds)
- Form 1099-B (stock or mutual fund sales and certain other transactions by brokers)
- Form 1099-S (proceeds from real estate transactions)
- Form 1099-K (merchant card and third party network transactions)

- Form 1098 (home mortgage interest), 1098-E (student loan interest), 1098-T (tuition)
- Form 1099-C (canceled debt)
- Form 1099-A (acquisition or abandonment of secured property)

Use Form W-9 only if you are a U.S. person (including a resident alien), to provide your correct TIN.

If you do not return Form W-9 to the requester with a TIN, you might be subject to backup withholding. See What is backup withholding? on page 2.

By signing the filled-out form, you:
